### Great AABE Speeches continued.

AABE National President and Chief Operating Officer Frank Stewart informed the breakfast audience on how "Water is the New Oil." He discussed how the affects of drought conditions and environmental hazards disproportionately affects Africans and Black Americans.

Dr. Woodrow Whitlow, Jr., Director of the National Aeronautics and Space Administration's (NASA) Glenn Research Center, took the AABE membership to the great beyond. Dr. Whitlow provided a history of how NASA revolutionized the renewable energy industry with ground breaking technology and included plans for future space exploration.

**Texas State Representative** Harold Dutton provided us with a history of the formative years of AABE. Rep. Dutton is a former Board member with AABE and was instrumental in directing our organization to expand with local chapters. Harold is the Founder of the AABE Houston Chapter. Congresswoman Sheila Jackson-Lee provided a na-

tional and international perspective on issues related to energy and homeland security during the "Securing our Energy Borders" Session. Congresswoman Lee is the driving force behind the Congressional Black Caucus' "Energy Brain Trust."

Gulf Power Company President & CEO **Susan Story** gave a moving speech about the challenges women face as corporate executives in a male dominated industry during the CEO Roundtable Session.

Ellen Petrill, Director of Public/Private Partnerships for EPRI, entertained the audience by providing examples of how the nanotechnology industry has become "mild, wild and crazy" as it develops innovative and fun tools to revolutionize energy applications in the future.

Michael Morris, Chairman, President & CEO of American Electric Power, expressed his views about corporate commitment to energy conservation, global warming issues and to support minority communities affected by environmental hazards.

Leo Sherman, Chief Pilot for Continental Airlines and member of the Organization of Black Airline Pilots (OBAP) shared his experiences flying across the globe and how the aviation industry is coping with rising fuel prices and new carbon emission reduction requirements for airplanes.

**Dr. Isaac Crumbly**, Student Chapter Coordinator at Fort Valley State University (FVSU) presented to the Board the successes of FVSU's Minority Engineering Program.

Dr. Randal Pinkett. Chairman & CEO of BCT Partners and winner of NBC's The Abprentice - Season 4, was the keynote speaker at the James E. Stewart Gala. Randal urged the crowd to explore and promote new opportunities as entrepreneurs in the energy industry. His speech also focused on the challenges we face as African-Americans in the professional arena. Dr. Pinkett acknowledged the experiences and commitment of AABE's founding fathers along with our mission as an advocate for minorities affected by energy issues.

### AABE National Office Report - 1st Quarter 2008

The National Office participated in the Global Roundtable on Climate Change hosted by Columbia University. The discussion focused on the directions and outcomes of the Bali Climate Change Conference. Of particular interest was the review of various fledgling cap & trade programs and national adaptation efforts or activities being put in place to mitigate the risks of climate change.

AABE was asked by Operation Push to develop a session on renewable energy technologies for the Push annual Wall Street conference. DC Chapter President **Derek Dyson** and Houston Chapter member **John Q. Moaning**, CEO of Blue Diamond Ventures, offered a very compelling session on the entrepreneurial opportunities in these new energy technologies.

The Office has been in touch with the Environmental Protection Agency (EPA) regarding the possibility of developing a memorandum of agreement to establish an on-going consultative relationship. Given the expected role that Congress will assign to the EPA

regarding climate change may well require a significantly expanded role for the agency, particularly regarding communications with Minorities.

On February 12th, the Office participated as a panelist for a discussion on global climate change at the National Petrochemical and Refiners Association's Environment Committee Meeting. The discussion dealt with the social, economic and political impacts of the leading approaches to the mitigation of an adaptation to climate change.

The Office served as the AABE representative & delegate to the Washington International Renewable Energy Conference from March 3rd to March 6th. During the conference, AABE and the US-DOE were party to sidebar meetings with the Energy & Mining Minister from Morocco and the Energy, Mining & Environment Minister from South Africa. The purpose of the meetings was to establish a relationship between all parties.

AABE met with the Joint Center for Political & Economic
Studies and the Bipartisan

Policy Center to discuss a potential collaboration on providing energy and environmental information to the minority community. The discussion involved a potential role for AABE on a series of advisory groups and other forms of consultations.

Dr. Patrick Wilson of the Food and Drug Administration (FDA) invited AABE to participate in a series of training efforts in Botswana, Liberia and Nigeria in an effort to increase the participation in trade authorized by the African Growth and Opportunity Act (AGOA). This training is scheduled to begin this summer and to continue for several months. The role for AABE will be to consult on the energy implications of increasing the level of trade in agriculture and agricultural-related products.

"Energy Justice Concerns Minorities" By **Morgan Josey Glover**, Staff Writer, Greensboro, North Carolina News & Record – February 22, 2008

Black energy industry professionals concerned about the vulnerability of low-income minorities to supply and price volatility want to have a greater say in the distribution of fuel, electricity and other energy sources.

"Energy is probably one of the most important topics at this time," said Wilton Cedeno (ConEd – NYMAC), Chairman of the Board of Directors for the American Association of Blacks in Energy (AABE). "It is not true to say these issues are not relevant to African-Americans and they are not involved." On February 21st, AABE and NC A&T University (pictured above) co-sponsored a conference in Greensboro to discuss initiatives and a possible partnership that would offer mentoring and provide scholarships and internships to engineering students.

Members now are tackling environmental and social justice concerns as fuel and electricity become more expensive and some scientists attribute severe weather in the US and Africa to climate change. For example, US unemployment among Blacks outpaced that of

Whites after the Middle East oil embargo during the 1970s, said **Leslie Fields**, Director of Environmental Justice for the Sierra Club.

Low-income households and small businesses could also suffer lost wages and revenue, disruptions in mass transit and health problems if extended electricity outages occur similar to those in New Orleans after Hurricane Katrina, said Morry Davis (Peabody Energy), AABE National LIPP Committee Energy Principles Co-Leader. Creating policies that equitably distribute resources will be key to overcoming these challenges. "If this doesn't happen correctly, this will have a profoundly negative impact on the African-American community," Davis said. "How do we make this an even playing field for everyone?"

Presentations held during the AABE NC Chapter Energy & Environment conference included executives from the AABE National Office, various government representatives, NC Sustainable Energy Association, Progress Energy, Advanced Energy, and the Department of Energy.



#### Kyle's Korner

"Enter Brazil: The New Oil Heavyweight of the World"

Brazil, once considered a relative afterthought in the global oil marketplace, has some energy analysts changing their forecast assumptions. After a recent announcement in 2008 of a massive oil discovery off the coast of Brazil in the Carioca-Sugar Loaf, which the Brazil National Petroleum Agency (NPA) estimates contains as much as 33 billion barrels of oil, the nation catapults into eighth position in the global oil rankings. This discovery is the third largest ever and is adjacent to the Tupi Field. Brazil's last major oil discovery came in 2007 when oil was discovered in the Tupi field, which analysts suspect will produce between 5 billion and 8 billion barrels. This additional oil field discovery is quite fortuitous for Brazil. Brazil's oil reserves were suspected to be relatively modest at about 12 billion barrels at the beginning of 2007, or about 1% of the world's

Both Tupi and the Carioca-Sugar Loaf, lie beneath a thick layer of salt that is some 500 miles long and 125 miles wide. Petrobras (the state owned oil company of Brazil) and its partners, BG of Britain and Repsol-YPF of Spain are heading the drilling efforts. The firm's head of exploration says, "There is practically no exploratory risk" in the area.

**Dilma Rousseff**, Petrobra's chairman has declared that Brazil will soon be on a par with Venezuela or

Brazil's Petrobras P-40 oil platform Saudi Arabia. The government must be thrilled at the prospect of the revenue from the new fields but they will take many years and huge sums to develop

(drilling a single well at Tupi cost \$240m).

Goldman Sachs has coined the term "BRIC", for what it considers the future economic powers in the world. "BRIC" stands for Brazil, Russia, India, and China. Brazil, although modest when compared to China and India, experienced 5.4%—GDP growth last year. Brazil has grown at an average of 4.5% since 2004 and grew an average of 7% between 1940 and 1980.

Recent reports have indicated that Brazil has been receiving offers to join the Organization of Petroleum Exporting Countries (OPEC). However, At the Energy Information Administration's 2008 conference held in Washington D.C. April 7-8, I confronted the head energy analyst of Lehman Brothers who said that not only was there no assumption of the sort built into his forecast model but that he hadn't even heard that Brazil had received any offers to join OPEC. Brazil joining OPEC would certainly be troublesome for the US as it attempts to move away from dependence on the whim of the oil cartel. Whatever Brazil eventual decision may be regarding membership in OPEC, one thing is certain, Brazil has entered the arena of global economic powers.

#### US Nuclear Energy Generation Makes Record

EIA Press Release - March 31, 2008

The U.S. nuclear industry supplied a record 806.5 billion kWh of electricity in 2007. The largest increase came in Tennessee, with 4 billion kWh more nuclear-provided electricity in 2007 than in 2006, an increase of 16 percent, according to preliminary US Department of Energy's (DOE) Energy Information Administration (EIA) data released today.

National total nuclear generation was 2.4 percent higher than in 2006, and 2.3 percent higher than in the previous record year, 2004. The capacity factor (the amount of power actually generated compared with the maximum amount that could be generated) for 2007 was 91.8 percent, exceeding the previous record capacity factor of 90.3 percent in 2002.

The total number of operating commercial nuclear reactors in the U.S. increased from 103 to 104 in 2007 with the return to service of the Brown's Ferry I reactor, which had been shut down in 1985. The total number of operating U.S. commercial reactors remains well below the peak level of 112 in 1990. However nuclear power generation in 2007 was 40 percent above the 577 billion kWh produced in 1990, largely reflecting a major improvement in utilization rates.
